**Guidelines: Please read and follow carefully or your entry may be disqualified**

1. Entries must be 4" x 6" prints. The photo, or one similar to it, may not have been published, nor have won, or be currently entered in any other exhibit. Prints must be submitted with no frame or matting. Do not print your name or title on the front side. You can also turn your photos in electronically. Photo must be able to be printed on a 4"x6" paper size. If it does not, the photo will be disqualified.
2. Participants may enter only one photo per category. Each photo submitted must have a completed official entry form attached. Do not attach 2 or 3 photos to one entry form, if so, the entry will be disqualified.
3. All printed photos must have the employees name, location and category written on the back.
4. All of the Parkwide finalists will be exhibited on ycerp.org. By submitting this photo you are granting permission to the Yellowstone Co-Op Employee Recreation Program to use them for display in electronic and print form.
5. Photos must be taken during the spring/summer of 2019 or late summer/fall of 2018.
6. National Park Service regulations must be followed. Any photos that show violations of park regulations will be disqualified. Specific regulations are as follows: THERMAL AREAS: You must stay on board walks and designated trails. WILDLIFE: You must stay at least 100 yards/ 91m away from bears and wolves and at least 25 yards/23m away from all other animals—including bison, elk, bighorn sheep, deer, birds, moose, and coyotes.
7. Photos of wildlife in captivity will be disqualified.
8. No alteration or retouching of the original image or print is permitted.

All entries will be pre-screened and then displayed for judging. Public judging will occur on August 20, 21, 22. Winners will be announced shortly after. The Parkwide YCERP Office will return the photos to the office where they were originally submitted. **Photo entries will not be mailed back to the entrant's address. They must be picked up at the office where they were originally submitted.**
